#### **CONVENTION RULES**

- The voting body consists of two accredited delegates from each society, the voting members of the Board of Directors (elected officers, zone presidents and chairmen of standing committees) and past SWD Presidents who are currently LWML SWD members. (Article V, Section B.3) Pastoral Counselors are Advisory Members. (Article XII, B)
- 2. A majority of the registered voting body shall constitute a quorum.
- 3. Only those delegates who have registered with the Registration Committee and are given the identifying badge may vote. Delegates will sit in the section reserved for voting members and wear their badges for the day. (An alternate may vote in the absence of the delegate and will sit in the section reserved for the voting body when acting as a delegate.)
- 4. Only members of the voting body have the right to speak and vote (Article V, Section B-3).
- 5. Any voting member wishing the floor shall give her name, zone, and church or office in order to be recognized.
- 6. Discussion is limited to fifteen (15) minutes on any question and to two (2) minutes for each speaker. No one may speak more than twice on the same subject without the consent of the voting body, the second opportunity being granted only after every other delegate desiring the floor for the first time has spoken.
- 7. A motion must be presented to the President in writing, signed by the maker, if so requested by the President.
- 8. The Chair shall be empowered to appoint such committees as shall be necessary for the conduct of the convention
- 9. The Chair shall be empowered to appoint a Minutes Review Committee to approve the minutes of the convention after the close of the session.
- 10. All announcements shall be handed to a page or usher who will deliver them to the Chair.
- 11. The sale of items at convention is limited to the printed or recorded publications of the guest speaker's related topic, as well as Christian Life products and Concordia Publishing House items. Non-LCMS speaker's items need EC approval six (6) months in advance of the event. (Adopted by Board of Directors, September, 2005.)
- 12. Cell phones, pagers and other electronic devices must be turned to "off" or "vibrate" during convention sessions.
- 13. These rules may be suspended by a two-thirds (2/3) vote of the voting body.

# Visiting LWML BOD Representative



Karen Morrison, Vice President of Gospel Outreach

Karen and John have been married for 28 years. Between them, they have four grown children, two daughters-in-law, and one son-in-law. They have been blessed with eleven grandchildren, ranging in age from high school to a one-year-old. She loves being 'MeMa' and watching as each one grows into the person God intends them to be.

# Guest Speaker Carolyn Blum

I truly feel God chose me to serve Him through the LWML. However, my first responses when asked to participate were always, "I could never do that!" Which was true — I definitely could not do it — but if I just got out of God's way, He would work

through me to make it happen. Thus Ephesians 3:20-21 became my guiding verse: Now to Him who is able to do immeasurably more than all we ask or imagine, according to His power that is at work within us, to Him be glory.

Through God's guidance and mentoring by many kind and patient friends, He enabled me to serve as a short-term missionary, president of our district, an LWML vice president, an editor of the Lutheran Woman's Quarterly, and author of an LWML history book. And along the way, He provided many humbling, humorous, and sometimes bizarre experiences to keep life interesting.

## Mission Grant Proposal Summary for 2024-2026 Biennium

- # 1 Lutheran Church Charities Comfort Dogs-WI \$21,000 There are 7 comfort dogs with host families/congregations/institutions in South Wisconsin. Often, they are called upon to deploy to disaster areas and this expense is "out of pocket" for those sponsoring the dogs. These funds would be equally distributed between the host dog entities to supplement their support/care/travel funds.
- # 2 Reaching Visually Impaired Inmates/Prison Inmates with God's Love \$10,000 Lutheran Braille Workers (RSO) is requesting this money specifically to help fund the production of Prison Ministry Bibles, Bibles studies, or other Christian materials at Ministry Production Centers in the US and utilize prison Braille transcription programs in Wisconsin or elsewhere in the US to transcribe new Christian materials into Braille, so inmates in prison will know Jesus as their Savior.
- # 3 CTSFW, Fort Wayne, IN, Food Co-op \$15,000 The Food and Clothing Co-op at Concordia Seminary, Fort Wayne, works to encourage and financially support students through its programs. The request for \$15,000 is specifically to purchase perishable food items for the 2024-2026 biennium.
- # 4 Bethany Ev. Lutheran Church Ministry Outreach \$14,000 Bethany Lutheran Church has a presence in inner city Milwaukee ( N. 38th St) and has made it a priority to reach into the neighborhood offering both physical and spiritual care to the residents there. To continue what has begun, the church is looking for this money to supplement their current efforts over the next two years, along with the support of SWD and other churches.
- # 5 Office Equipment and Supplies for Peace Valley Lutheran Church \$7,500 Peace Valley Lutheran Church is the new SWD church plant in Monticello, Wisconsin building an LCMS presence where none had been. They are renting a space for worship but could use help with office equipment and supplies to be able to do the communication piece necessary for their continued growth.
- # 6 Orphan Grain Train Wisconsin Branch \$15,000 While the Orphan Grain Train (RSO) continues to receive needed humanitarian supplies through donations which are then distributed both nationally and internationally, it requests funds to assist with the cost of shipping. Costs to ship a container may vary from \$6,000 to \$12,000 and they are on record for shipping at least 12 per year.
- # 7 Teaching God's Children with Special Needs \$50,000 Journeys Lutheran School (formerly Lutheran Special School) continues to embrace students in grades 3-12 with special needs. Their programs facilitate the educational goals of individualized instruction and growth along with the sharing of the Gospel. This request is toward the purchase of 2 passenger vans which will be used to transport students to field trips and other opportunities supplementing what they currently do as well as use in the school to work program.

#### Summary of Mission Grant Proposals for 2024-2026 Biennium (cont.)

- # 8 Life-Changing Care for People in the Dominican Republic Living with Intellectual and Developmental Disabilities \$18,000 These funds will help to partially fund the cost of the care, education, rehabilitation, and spiritual life program of the residents of the Dominican Republic group home as well as outreach and care to others with intellectual and developmental disabilities in the communities where the 5 Dominican LCMS Lutheran congregations are located. Deaconess Danelle Putnam will be responsible for this grant requested by International Missions, LCMS.
- # 9 Camp LuWiSoMo Camper Scholarships \$20,000 Camp LuWiSoMo in Wild Rose, WI works with families that cannot afford the full cost of camp for their children. This Scholarship Fund has been a vital part of assisting them to make it possible to pay the fee so that many children who otherwise would not be able to attend camp are able to do so. (RSO)
- # 10 Theological Libraries and Resources for Africa \$10,000 The Office of International Missions is proposing the allocation of \$10,000 specifically "to help fund 'Theological Libraries and Resources Africa' to support and expand theological training through seminaries in Africa under the direction of Rev. Shauen Trump."
- # 11 SWD Church Worker Grant \$30,000 The South Wisconsin District office allocates scholarships to students enrolled in a Concordia University and intending to serve the church as a pastor, teacher, deaconess, etc. Over the next two years this money will be distributed to those who apply and qualify.
- # 12 Hope Lutheran Church Outreach Ministries Fund \$25,000 Hope Lutheran Church, located at 35th and Highland in Milwaukee, has a number of neighborhood outreach programs. This allocation of money would be \$5,000 to each of the following programs: 1) Grief Share, 2) First Friday (children and youth), 3) Sunday School, Adult Bible Study and Summer Bible School, 4) Hope Lutheran Church Food Pantry, 5) Pastor's Lot Outreach (mercy ministry distribution of food, clothing)
- # 13 Telling the Next Generation: Lutheran Books for Southeast Asians \$12,000 For years, the Lutheran Heritage Foundation has been printing and distributing books around the world in various languages. They are asking for this money to help print more than 2,000 Lutheran books in Southeast Asia as well as for immigrants here in Wisconsin and other parts of the US so the Word can go out in the language of the people. (RSO)
- # 14 Trinity Evangelical Lutheran Milwaukee Restoration \$25,000 In 2018, historic Trinity Lutheran Church in Milwaukee was extensively damaged by a fire. Insurance covered 67% needed for reconstruction. Further funds are needed to refurnish the sanctuary so that the presence of Trinity stays strong in the downtown area.
- # 15 The Lutheran Counseling and Family Services of WI Child Therapy Expansion Mental Health Coverage \$25,000 With the counseling skills of the staff at LCFS and a vision of expansion to serve more youth, the goal is to expand the Child Outreach Therapy program that reaches children and their support networks and brings them to a better place in life through the message of the Gospel.

#### Summary of Mission Grant Proposals for 2024-2026 Biennium (cont.)

- # 16 The Phoebe Initiative \$5,000 Concordia Seminary in St Louis has a Deaconess Studies program educating young women in the Scriptures and working to hone their skills for a work in a variety of fields after graduation. They are asking for the sum of \$5,000 "to provide vital support for Concordia Seminary's Deaconess Studies programs."
- # 17 Youth Navigating in this World \$20,000 The final Whereas in this application reads: "having received its RSO status with the LCMS, is seeking to become a partnership hub for ministry among the congregations and schools of the city of Milwaukee, ..." The SOS Center is in the heart of Milwaukee where the need is great to witness to and strengthen the family. It is the goal of SOS to offer classes and activities to help youth become confident and focused members of society. They plan to do this through small group Bible study, music, public speaking, cooking and sewing classes, technology opportunities, grief share and peer support groups. This money will help with supplies and staff stipends.
- # 18 Physical Wellness for At-Risk Children \$10,000 Dakota Boys and Girls Ranch (RSO) exists to offer at-risk youth the knowledge and skills to succeed in the name of Christ. At this time, they are seeking funds specifically for the updating of the gym floor on its Minot campus.
- # 19 Ministry Scholarships for Shepherd's Canyon Retreats \$15,000 Shepherd's Canyon Retreat is designed for and utilized by LCMS church workers in need of spiritual renewal and encouragement. It is an RSO and offers week-long counseling retreats in a comfortable, healing setting. They are seeking funds to be able to offer \$500 scholarships to pastors and ministry workers and their spouses to benefit from this experience and bring it back to the local level in renewed vigor for ministry.
- # 20 A Place of Refuge LCMS RSO \$11,000 This LCMS prolife ministry has been active in the Milwaukee area for a number of years. It sustains an advocacy program, housing for pregnant women and a resale store that generates funds for the ministry. At this time in history, some upgrades are needed. This \$11,000 will go toward recarpeting portions of Blessed Again Resale and for the purchase of a safe for important documents.
- # 21 Christ Evangelical Lutheran School Playground \$25,000 Christ Lutheran School in West Bloomfield (Weyauwega area), desires to provide a safe and attractive place for their children to play and to be a witness to the community as well (the community does not have a public park). Not having sufficient funds on their own to undertake such a project, they are hoping that LWML can add to the success of their vision.
- # 22 Teacher Training Workshop, Martin Luther Academy BO, Sierra Leone \$5,000 Lead a Child (an RSO) is active in Sierra Leone. With this grant request, they hope to host a teacher training workshop for educators serving at Martin Luther Academy in Bo, Sierra Leone. The goal is to raise up model teachers who are able to effectively teach and communicate the Gospel.
- # 23 Lutheran Neighborhood Schools Initiative \$50,000 The SWD is rethinking how "school" looks. Micro schools in local areas will provide Lutheran Christian education to a wider population of students in the Milwaukee area with hopes to expand. These funds would be used, equally divided, for scholarships to ensure that every student can attend LNS and the other half to renovate new LNS sites to bring them into compliance with building codes.

I also noted an adjustment made by Wendie Staus on April, 1, 2023 to move \$78.75 (3 societies) from "Memorial/Celebrations" to "Anita Goede Golf Outing" (column "Goede Golf Tee Up").

My one recommendation to help the Financial Secretary is to get more or all societies to use the most current voucher form and to note that one of those should be submitted along with Quarterly order forms. When an old form is received, have the Financial Secretary send them a sheet of 3 current forms that they can photocopy until that Financial Secretary's term expires or form designated fund categories are revised or updated.

RE: Financial Review for period July 1, 2021 – March 31, 2022

I was asked to review the financial records of the Lutheran Women's Missionary League – South Wisconsin District (LWML – SWD). This review covers the financial period of July 1, 2021 through March 31, 2022.

This was a financial review, not an audit. Both provide levels of assurance that the financial statements issued by the organization are free from material misstatements as required by accounting guidance (referred to as Generally Accepted Accounting Principles, or GAAP).

An audit will provide the highest level of reasonable assurance, while a financial review will provide limited assurance. In a financial review, interviews, analytics, and test are performed. An audit increases the level of assurance by including more detailed scope of internal control systems, physical observation of systems and confirmation of balances with external parties.

The purpose of a financial review for a nonprofit is to support the treasurer in her duties, to verify that the records are consistent and communicated to appropriate members, and to offer suggestions for improved controls and efficiencies.

To facilitate this review, I followed the financial review guidance as issued by the Lutheran Church – Missouri Synod 2015 Congregational Resources. This guidance provided a general framework for the review.

#### Evaluation:

During the review process, I gained an appropriate level of limited assurance that the financial statements from July 1, 2021 through March 31, 2022 were free from material misstatements. I found that the LWML – SWD Treasurer followed the guidelines and recorded transactions promptly and consistently utilizing the Quick Books edition for nonprofit organizations. The invoices and vouchers had the required two signatures, and all reimbursements accompanied with the proper accounting category. The deposits were recorded as well. The LWML – SWD funds appear to be handled properly and in a timely manner.

October 5, 2022

Switching the fiscal year end to March 31<sup>st</sup> to be consistent with the National LWML seems to have been a good decision for both our Treasurer and Financial Secretary. Due to the change of the SWD fiscal year voted on at the 2022 District Convention, the financial statements for the July 2021 to March 2022 biennium were reviewed after the convention and will be printed in the 2024 convention manual along with the 2022-2024 biennium treasurer reviews.

It is also a good idea and makes sense that the Treasurer is also now serving as the treasurer of all retreats, plus having the bank issue checks for vouchers, etc. This process also saves LWML postage and envelopes.

I was asked to review the Treasurer's records of the Lutheran Women's Missionary League - South WI District, covering the period of 4/1/22 – 3/31/23.

This was a treasurer's review not an audit. Both provide levels of assurance that the financial statements issued by the organization are free from material misstatements as required by accounting guidance (referred to as Generally Accepted Accounting Principles, or GAAP). An audit will provide the highest level of reasonable assurance, while a treasurer's review will provide limited assurance. In a financial review, both interviews, analytics, and tests are performed. An audit increases the level of assurance by including detailed tests and evaluations of internal control systems, observing systems, and confirming balances with external parties.

The purpose of the financial review for a nonprofit is to support the treasurer in their duties, to verify the records are consistently maintained and communicated to appropriate members, and to offer comments to improve efficiencies.

To facilitate this review, I followed the financial review guidance as issued by the Lutheran Church – Missouri Synod through their Congregational Resources documentation. This guidance provided a general framework for the review. Specific steps include the following:

Inquiry of organizational structure.

Inquiry of controls over cash handling.

Review of provided board and executive committee minutes for meetings held within the periods of review.

Review of bank account reconciliations.

Comparison between board reviewed financials and system data.

Detail testing of a selection of cash receipt and cash disbursement transactions.

Review of the financial statements in the accounting system – QuickBooks.

#### **Evaluation:**

Through the review process I gained an appropriate level of limited assurance that the financial statements for April 1, 2022, through March 31, 2023 were free from material misstatements. I found that the LWML-SWD Treasurer followed the guidelines and recorded transactions promptly and consistently using double verification through Excel and QuickBooks. All reviewed invoices/vouchers had the required two signatures, and all reimbursements were recorded using proper accounting categories.

#### **Treasurer Review (cont.)**

May 9, 2023

#### Comments:

Having been the LWML-SWD treasurer many years ago, I have a profound appreciation for the evolution of the accounting and reporting systems, technology and safeguards that are now in practice. Having the treasurer handle the finances of the other LWML-SWD events has increased her workload but added a measure of consistency in budgeting, accounting, and reporting. I have great confidence in the Treasurer and admire her organizational skills, proficiency, attention to detail, dedication to the LWML and it's work, and to constantly improving and automating our financial reporting system. We are blessed to have her.

#### Additional comments/recommendations:

I appreciate the treasurer having an LWML-SWD issued laptop, with cloud-based software, facilitating use between her and the financial secretary or EC if necessary. It will make the transition much easier when a new treasurer is elected. I would recommend that each EC member have an LWML-SWD laptop as well.

Reimbursement/expense checks, submitted by our software to the financial institution and issued and mailed by them is a great benefit and cost/time savings.

The new March 31 accounting end date is a plus.

Continue to increase automation and decrease paperwork.

#### **Treasurer Review**

I was asked to review the Treasurer's records of the Lutheran Women's Missionary League – South WI District covering the period 4/1/23 – 3/31/24.

This was a treasurer's review not an audit. Both provide levels of assurance that the financial statements issued by the organization are free from material misstatements as required by accounting guidance (referred to as Generally Accepted Accounting Principles, or GAAP). An audit will provide the highest level of reasonable assurance, while a treasurer's review will provide limited assurance. In a financial review, interviews, analytics, and tests are performed. An audit increases the level of assurance by including detailed tests and evaluations of internal control systems, observing systems and confirming balances with external parties.

The purpose of the financial review for a nonprofit is to support the treasurer in their duties, to verify the records are consistently maintained and communicated to appropriate members and to offer comments to improve efficiencies.

To facilitate this review, I followed the financial review guidance as issued by the Lutheran Church – Missouri Synod through their Congregational Resources documentation. This guidance provided a general framework for the review. Specific steps include the following:

- Inquiry of organizational structure
- · Inquiry of controls over cash handling
- Review of bank account reconciliations
- Detail testing of a selection of cash receipts and cash disbursement transactions
- Review of the financial statements in the accounting system QuickBooks

#### Evaluation:

During the review process, I found that the one-time gift from the National LWML of \$7,000.00 to the hosting districts of the LWML 2023 Convention was correctly recorded as income but it was posted into the Administrative Fund. It should have been posted into the Female Church Work Scholarship Fund. The Treasurer has made the correcting entries and the FCW Scholarship Fund now has a total of \$14,580.00. I completed the review of the financial statement ending March 31, 2024 on April 10, 2024 and this enabled the Treasurer to correct the financial statements to be printed in the convention manual.

After the corrections were made, I find that the financial statements for April 1, 2023 through March 31, 2024 are in good order. I found that the LWML – SWD Treasurer followed the guidelines and recorded transactions promptly and consistently. All reviewed invoices/vouchers had the required two signatures and all reimbursements were recorded using proper accounting categories.

#### Comments/recommendations:

- The new March 31 accounting end date is excellent. It helps in the transitioning to the newly
  elected Treasurer and Financial Secretary. Also the financial statements can be reviewed and
  corrections made, if needed, before the June District Convention.
- I feel the communication between the Treasurer and Financial Secretary, of sharing certain excel spreadsheets is very important.
- The reimbursement/expense checks submitted by our software to the financial institution and issued and mailed by them is a great benefit and saves on ordering checks.
- We need to continue to increase automation and decrease paperwork.

These financial statements are for the two year biennium of April 1, 2022 thru March 31, 2024.

Page 1: Comments

Page 2: Everything about mites.

Page 3: Where is the money?

Page 4: Donations/Money Received

Page 5: Expenses/Funds Distributed

Let's look at some items:

- A. LWML MITES RECEIVED: \$217,866.72 was received for mites and was allocated 25% to LWML and 75% to LWML SWD mites. That figure is shown on Page 2 at the top and on Page 4 near the middle. Our goal was \$205,000 and we exceeded that by \$12,866.72.
- B. LWML MITES PAID TO LWML: \$54,466.68 (25% of \$217,866.72) was paid to LWML as shown on Page 2 near the top and on page 5 near the middle. We exceeded the amount of \$51,250 that we promised to send LWML by \$3,216.68. We did also receive \$100 that was directed to be paid solely to LWML mites.
- C. LWML SWD MITES RECEIVED: On page 2-in the top half is \$194,608.28, which is the total raised for LWML SWD mites this biennium. That includes our 75% plus interest, special gifts, \$60.91 from the prior biennium, and a \$25,000 grant from a prior biennium which was returned and voted at the 2022 LWML SWD convention to be used for this biennium grants.
- D. LWML SWD GRANTS PAID: On page 2 at the bottom and on page 5 in the middle \$178,060 was paid for SWD grants selected in June of 2022. Note that one grant was issued in December of 2022 and returned in July 2023, so those funds were again available to pay the next grants. We added one grant (grant #12 from the 2022 convention selection) and paid 100% of the grant requested for the 11th grant selected.
- E. FEMALE CHURCH WORK SCHOLARSHIPS: On page 3, there is \$86,768.91 in the FCW scholarship accounts. The frozen base is \$75,000. That base earns interest for scholarships. Income also comes from special gifts and 25% of fall retreats and winter getaway offerings. On page 4 near the bottom, it shows donations of \$14,580.00 (This amount includes a one-time gift of \$7000 to the hosting districts of the LWML 2023 Convention.) and interest of \$2,912.02 for scholarships. For both the 2022-2023 school year and the 2023-2024 school year, we were able to award \$6000 per year for the FCW Scholarships. That total of \$12,000 awarded is on page 5 near the bottom. We only budgeted for \$10,000 but were able to give more!
- F. LWML SWD TLC (THE LOVE OF CHRIST): The Love of Christ Fund was set up with \$25,000 to provide monies to give financial assistance to those wishing to attend LWML SWD conventions and retreats who might not otherwise be able to afford to attend. Income comes from 25% of LWML SWD convention offerings, special contributions and interest. Currently there is \$77,734.53 in those TLC accounts as shown in the middle of page 3. This biennium we used \$1431.25 of funds as shown on page 5. Page 4 near the bottom shows that \$1,552.94 was donated to this account, and \$2,034.62 of interest was earned. A TLC Task Force has been formed to review the guidelines for this fund and evaluate what are we able to do with this fund that is earning more interest than is being distributed per year. BUT get the word out that these funds are available to cover registration and hotel costs for people wishing to attend retreats and convention. Don't let cost deteranyone!
- G. SUPPLIES EXPENSE: Supplies expense shows on page 5 near the top has a negative figure because a computer purchased in 2021 was reclassified from supplies expense to the Computers account on Page 3 near the bottom. We have 9 laptop computers now, and plan to rotate the purchase and retirement of these computers. We will expense them when they are retired rather than when purchased. The plan is for all EC officers to transfer the computer with the position, so that ladies are not using their personal computers and transition is easier.

#### **President's Report**

I began this position in August 2022 when I met with the past chairman, Monica Jeske, as she passed her files and flash drive on to me. I established my committee and we began to work on revising the LWML SWD Convention Guidelines with input from the recent convention committee and the Executive Committee. These revisions were approved and new copies were distributed to Board of Director members at the February BOD meeting in 2023.

In the past year considerable work has been done revising and updating the General Guidelines for the district. This includes all the elected and appointed positions and also a few policy guidelines. The women in these positions are making sure the guidelines reflect the procedures that are currently being followed so that the guidelines will be useful as newly elected and appointed volunteers take on these roles.
